**1 ORDERING**

1.1 All orders of HOLM Ltd products are subject to availability and acceptance by us. We will contact you in the event that any HOLM Ltd product(s) you have ordered are unavailable. You will have the option either to wait until the HOLM Ltd product(s) in question are available from stock or to cancel your order.

1.2 In the event that we are unable to supply the HOLM Ltd products you have ordered either you or we may decide to cancel the order and we will reimburse your payment in full.

1.3 Please complete all the boxes on the order form. This is to ensure that we have all the necessary information to make a successful delivery. If you wish to have your HOLM Ltd products customised with a name, please complete the name personalisation box.

1.4 You agree and acknowledge to check your order before submitting it and in particular to check that the details of any customisation of HOLM Ltd products, including the spelling of any personal customisation requested by you, is correct. Once you have completed the order form return it to us at HOLM Limited, PO Box 246, Southampton, SO32 2YL.
